

### **Pre-Employment Medical Screening SOP**

With effect from 1st October 2008



Pre-Employment Medical Screening SOP 1. Mosques to send prospectives go for medical screening.

3. MDSU will issue the medical letter to mosques within 3 working days.

5. Staffs are to bring along the medical letter and screening fees to the clinic.


Each screening = \$26.75 / staff

2. Request medical letter from MDSU via email, letter or fax. Applicant's full name, identification card number and mosque's name required.

4. Upon receiving the medical letter, applicants are to undergo the medical screening immediately at any of the Raffles Medical clinics.

6. Raffles Medical will send the result slip to MDSU. MDSU will make a copy of the result and send the original slip to mosques. This process takes about 2 weeks to complete from the screening date.





## FAQs on Pre-Employment Medical Screening for mosque's job applicants.



No	Query	Answers
1	What is medical screening?	Pre-employment medical screening comprises of:  •A series of physical checks including fundoscopy, head and neck, nervous system, abdomen, musculoskeletal, and rectal examinations.  •Measurement of Blood pressure, height, weight and visual acuity.  •Chest X-ray - to check for possible pulmonary tuberculosis, pneumonia and other lung diseases.  •Urinalysis – A test to infer the state of kidney function as well as of the urinary tract.
2	Why do applicants have to do the pre-employment screening?	Pre-employment screenings are done to ascertain applicant's past and present medical history and whether they are fit for employment.
3	How much are the charges?	The current charges are <b>\$26.75 per staff</b> , inclusive of GST. This is to be paid by cash during the pre-employment check-up.
4	Where do applicants go for their screening?	Please refer to <b>Appendix A</b> for the list of Raffles Medical clinics with <b>X-ray</b> facilities.
5	What are the procedures?	Please refer to Pre-employment medical screening SOP.
6	Can mosques send their applicants to their preferred GPs?	Yes, but mosques are required to send a copy of the result slip to MDSU.
7	Can mosques employ applicants who have yet had their medical screening done?	It is <b>strongly discouraged</b> . If mosques hire the applicants without the medical screening done, mosques are fully accountable for any problem that might arise later.

#### **Security Screening SOP**

With effect from 1st October 2008



1. Mosques shortlist potential staffs to have their security screening processed.

Each application = \$6 / staff

3. MDSU submit the particulars and payment to MCYS.

- 4. The length of screening range from 1week to 2 months\* depending on MCYS' processing coordination.
- \* Do not employ until screening is cleared [Temp Staff (?)]



- 2. Mosques send applicants' particulars and screening fee to MDSU. The details required are:
- Applicant's full name,
- •I/C number,

- Date of birth,
- Home address,
- Post applied for,
- Brief job description &
- Mosque's name

5. MCYS will send the result to MDSU. MDSU will then inform mosques of the result.





## **FAQs on Security screening** for mosque's job applicants.



No	Query	Answers
1	What is security screening?	A Security Screening is a process where the applicant's background is being traced with the following agencies through MCYS: - Insolvency and Public Trustee's Office (IPTO) – for bankruptcy - Criminal Investigation Department (CID) – for criminal offences - Corrupt Practices Investigation Bureau (CPIB) – for corruption offences - Internal Security Department (ISD) – for national security and latent issues
2	Why do applicants have to be screened?	<ul> <li>This is because applicants, who are adversely traced on the records of ISD, shall not be offered appointment at the mosque.</li> <li>But MMBs are given the discretion to selectively employ applicants who are traced on the records of the IPTO, CID and CPIB</li> </ul>
3	Is the screening applicable to all mosque staffs?	Yes, <b>all staff</b> are to be security screened.
4	How much are the charges?	Muis will offer the screening services for <b>\$6 per person</b> . Please make the cheque payable to "Muis".
5	What are the procedures?	Please refer to Security screening SOP.
6	Can mosques employ applicants who have yet done their security screening?	It is <b>strongly discouraged</b> . If mosques hire the applicants without the security screening done, mosques are fully accountable for any problem that might arise later.
